## **General Terms**

## 1. Company Logo

#### Trademark owner:

#### Disclosure of company name and location together with logo:

When placing the logo on advertising materials, a producer must identify the insurance carrier's full name and primary office location - per NY State Insurance Law § 2122(b): ShelterPoint Life Insurance Company, Garden City, NY

## 2. Company Name

The company's full name **ShelterPoint Life Insurance Company** shall only be abbreviated as **ShelterPoint Life**. No other abbreviation of the company name is acceptable. Any deviation from this approved use of the company name shall be reason for ShelterPoint Life to immediately withdraw any permission for use of logo or naming of company.

## 3. Company Description

Any description with information about ShelterPoint Life or its services must be approved by ShelterPoint Life **prior to use**. A copy of the text intended for use must be attached to this agreement/application for use.

## и. Application for Use

- 1. Any producer wishing to use the logo/name and/or a company description on a website or in other marketing materials must **seek permission in writing** from ShelterPoint Life.
  - a. Permission may only be granted by ShelterPoint Life.
  - b. Permission must be granted in writing.
  - c. Use includes materials in any medium (including, but not limited to online, digital, print, video, audio) and any circulation size.
- 2. ShelterPoint Life will review **completed requests** based in part on the following **criteria**:
  - a. The extent to which the project of the applicant organization meets the objectives of ShelterPoint Life:
  - b. **How** the logo/name or company description will be used; and
  - c. The **context** for use of the logo/name and/or company description.
- 3. For use in **printed material**, a sample must to be submitted to ShelterPoint Life at time of application.
- 4. To use the logo/name and/or company description on a website, producer must provide the exact URL to ShelterPoint Life at time of application, including sub-pages on which the information will be placed.
- 5. The logo/name and/or company description shall only be used in the manner and format for which permission was granted by ShelterPoint Life. No one other than ShelterPoint Life shall make or approve alterations to the use for which permission was granted.
- 6. Producers shall use logo/name/description only on the specified medium/piece provided with the application. A separate agreement is required for each separate or additional use.
